Awards

Ribbons 1st—4th place in each jump height class to dogs with qualifying scores. Green ribbons will be awarded to all dogs with qualifying scores. Excellent B dogs earning a double Q will receive a special rosette while supply last after which they will receive a QQ pin. QQQ Pins will be awarded to Excellent B dogs earning a Triple Q. Club medallions or a rosette will be awarded to all dogs completing a new title. Dogs earning the MACH or PACH title will receive a special rosette and bar.

Show Hours

Judging will begin at 8:30 am each day. Show hours are 7:30 am—one hour after completion of judging.

Class Information, Jump Heights, Scoring

Classes offered: Regular Titling: Novice A & B, Open, Excellent A & B Standard, JWW, FAST and T2B. Preferred: Novice, Open, Excellent A & B for Standard, JWW, FAST and T2B.

Owners are responsible for entering the proper class and height. Complete rules can be found on the AKC website at www.akc.org. For a copy of the rule book write to: American Kennel Club, 8051 Arco Corporate Dr., Ste, 100, Raleigh, NC 27617-3390. To place a credit card order by telephone call: 919-233-9767 voice and 919-816-3627 fax. Minimum order is \$10. Obstacles will conform to the current edition of the AKC Regulations for Agility Trials.

Wait List: Vallejo DTC is offering a Wait List to fill openings created by withdrawn entries after the trials' closing date/time. A maximum of 100 runs will be placed on the club's wait list. All entries, including wait listed entries, must be received by the Trial Secretary prior to 6:00 pm on March 1, 2012. Any entries withdrawn that are received by 6:00 pm on March 13, 2012 will be replaced by a wait listed entry if any are available. If a withdrawn entry is replaced by a wait list entry, a refund will be issued and mailed in the time frame of 7 days before to 7 days following the event. Any wait listed entry that does not move off the wait list into the trial by 6:00 pm on March 13, 2012 will receive a FULL REFUND.

Notice to Exhibitors

- The trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds. Mixed breed dogs that have been listed with AKC Canine Partners may participate provided their listing number has been recorded on the entry form.
- Running order will be determined by random draw. Handlers with more than one dog in a class will have those dogs separated as much as possible.
- If a dog and/or handler are dismissed, regardless of the reason, there will be NO refund of entry fees.
- 50% refund for bitches in season after the closing date and up to the Friday before the event.
- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Trial Committee.
- No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- EXHIBITORS ARE RESPONSIBLE FOR COMPLETE, ACCURATE, AND LEGIBLE INFORMATION ON THEIR ENTRY FORMS; ILLEGIBLE OR INCOMPLETE ENTRIES CANNOT BE ENTERED IN THE TRIAL.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and /or children. Any exhibitor whose dogs and /or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any fees paid will be made.
- All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area.
- Exhibitors are responsible for being at the ring gate when it is their turn to run.
- Please be courteous and pick up after your dog.
- Dogs under six months of age are prohibited at AKC Agility Trials
- Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Rabies vaccine is required in the State of California
- Failure to follow the instructions of the Show Committee or their Agent will result in a Bench Committee Hearing
- Unsportsmanlike conduct will result in a Bench Committee Hearing.
- No refund for duplicate entry or entry in class that is not offered ie FAST or T2B on days not offered.
- Withdrawal of entry before closing date will receive refund less \$6 processing fee.
- Refunds are mailed in the time frame of seven days before to seven days after the event.

Both rings will be on the South lawn. Please allow the show committee to stake the rings and set up the show before setting up your canopies and campsites. No parking or driving on Dixon Blvd.

Course Familiarization/Warm-ups

Handlers in all classes are permitted to walk the course, without a dog, prior to the start of a class. The walk through is restricted to handlers entered in the class. A warm-up jump will be provided for each ring.

Move-Up Regulations

Dogs may be moved up to a higher class at the request of the owner, as a result of qualifying for an agility title, provided that the request is received in writing by the Trial Secretary, no later than 6 pm on the Monday preceding the event. Day to day move ups are allowed providing the Trial Secretary is notified at the show site, in writing, within 15 minutes of the last dog completing the course.

INSTRUCTIONS

Handlers may opt to enter in a higher **height division** for all **Regular** titling classes, but not in a division lower than their proper height division. Dogs entered in the **Preferred** classes **must** compete at the required jump height and **may not** compete in a jump height division **higher or lower** than their proper height divisions.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or **back-to-back trials** only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs enrolled in the **AKC Canine Partners** program may be eligible to enter all-breed AKC agility trials at the club's option effective April 1, 2010. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what relationship is the Junior Handler to the Owner? _____
