- ▶ PRE-ENTRY: \$15 per dog and \$10 per dog for second class. No Refunds after July 27, 2018-6:00PM
- ▶ LATE ENTRY: after July 27, 2018; \$15 per dog, no discount for multiple classes or multiple dogs.
- ▶ PLEASE NOTE NEW MATCH ORGANIZATION: There will be arm bands to be picked up at the main gate as you enter. We will run in numerical order. If you need to rearrange your order, please do so ringside with the steward. Current 'dog in ring' and 'next up' will be on a board at ringside.
- ▶ DAY OF MATCH ENTRY: Sign up between 8:00am and 10:00am. Day of match entries to run when time is available.

- ▶ SITE INFORMATION: Baseball field. Bathrooms are available. Minimal shade; you may want to bring canopies. *NO STAKING. BRING ALTERNATE STABILITY.* Bring chairs. Good parking. No food available.
- ▶ DIRECTIONS: Laurel Creek Park, Fairfield: Take Airbase Parkway exit #47 from I-80E or #47a from I-80W. Proceed east for 2 mi. to stop light at Dover Ave. Turn left on Dover, .5 mi to Cement Hill Ave. Turn right on Cement Hill for .7 mi to Laurel Creek Park. Park is on the left. When you enter the parking lot, keep to the right and drive to the end of the lot to the fenced baseball field.
- ▶ NO OFFICIAL AWARDS will be given, nor legs earned towards obedience or rally titles.
- ▶ CORRECTIONS AND REWARDS: Toys and food are permitted. Collars must comply with AKC regulations. No prong or electric collars are allowed. Corrections are limited to verbal corrections or gently guiding the dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons. I (we) agree that any cause of action, controversy or claim arising out of or related to the entry, exhibition or attendance at the event between the AKC and the event-giving club (unless otherwise stated in its premium list) and myself (ourselves) or as to the construction, interpretation and effect of this agreement shall be settled by arbitration pursuant to the applicable rules of the American arbitration association, however, prior to arbitration all applicable AKC bylaws, rules, regulations and procedures must first be followed as set forth in the ABC charter and bylaws, rules, regulations, published policies and guidelines.
